#### **Swachh Bharat Mission (Gramin)**

#### \*100. PROF. RICHARD HAY: SHRI GEORGE BAKER:

Will the Minister of **DRINKING WATER AND SANITATION** be pleased to state:

- (a) the salient features of the Swachh Bharat Mission (Gramin) along with its present status including the details of the funds sanctioned, allocated and utilized under this Mission across the country, State/UT-wise including Kerala;
- (b) the details of the targets set and achievements made under the Mission;
- (c) the number of Key Resource Centres (KRCs) identified under this Mission since its inception across the country, State/UT-wise;
- (d) whether these KRCs have played an important role in achieving the objectives of the Mission and if so, the details thereof; and
- (e) whether the Government proposes to identify some more KRCs across the country, if so, the details thereof and the time by which they are likely to be identified, State/UT-wise?

#### **ANSWER**

### MINISTER OF DRINKING WATER AND SANITATION (SUSHREE UMA BHARATI)

(a) to (e) A Statement is laid on the table of the House.

#### Statement referred to in reply to Lok Sabha Starred Question No. \*100 for 08.02.2018

(a) and (b) The Swachh Bharat Mission (Gramin) (SBM (G)) was launched on 2nd October, 2014 with the aim to attain Swachh Bharat by 2<sup>nd</sup> October 2019. The focus of the scheme is on behavior change and usage of toilets. Flexibility to States is being provided. There is focus on capacity building. Since the launch of Swachh Bharat Mission (Gramin) on 2<sup>nd</sup> October, 2014, 611.01 lakh toilets have already been constructed under SBM(G) as on 05.02.2018. Sanitation Coverage, which was 38.7% on 2.10.2014, has increased to 77.52% on 05.02.2018. 312 Districts, 2803 Blocks, 1,39,386 GPs and 3,16,670 Villages have been declared Open Defecation Free (ODF) as on 05.02.2018. In addition, 11 States/UT namely Sikkim, Himachal Pradesh, Kerala, Uttarakhand, Haryana, Gujarat, Chandigarh, Daman and Diu, Arunachal Pradesh, Chhattisgarh and Meghalaya have also been declared ODF. State/UT-wise, central share released and utilized under SBM(G) during last 3 years and current year is placed at Annexure-1.

(c) and (d) 36 Key Resource Centres (KRCs) have been empaneled by the Ministry for providing Capacity Building support to the States. Guidelines for the KRCs were also revised. All the KRC's have been oriented and a training module (termed as Community Approaches to Sanitation (CAS) Module) has also been developed and provided for conducting and scaling up the capacity building programme in respective States.

The training module consists of five documents that includes; one-day training module for senior level managers, two-day training module for mid-level managers, five-day training module for community facilitators/motivators, three-day training of trainers (TOT) module for trainers and a facilitators' guide for conducting the training programmes using these modules.

The KRCs are actively being engaged by the States for providing grassroots trainings to districts / Block Officials / Swachchagrahi etc.

(e) This will depend upon requirements expressed by States and the evolving national priorities of the Mission.
