'TEST AND TREAT' POLICY FOR HIV PATIENTS

149. SHRI V. ELUMALAI:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) whether it is true that the Government's new test and treat policy for HIV will now have the National AIDS Control Organisation focusing on community based tests to detect hidden cases;
- (b) if so, the details thereof;
- (c) whether it is also true that there are 10.50 lakh people with HIV on antiretroviral treatment and if so, the details thereof;
- (d) whether with the revision in the guidelines, NACO is likely to detect another three lakh cases and if so, the details thereof; and
- (e) whether it is also true that out of the 21 lakh estimated to be living with HIV only 14 lakh patients are on records and if so, the steps taken in this regard?

ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SMT. ANUPRIYA PATEL)

(a) & (b): The test and treat policy launched by the Government mandates treat all people living with HIV (PLHIV) with anti-retroviral therapy regardless of CD4 count, clinical stage, age or population.

Community based testing is testing of 'at risk' population, which is so far unreached, through outreach activities at a place convenient to them.

- (c): 11.81 lakh people with HIV are on anti-retroviral treatment as of December 2017. The details are annexed.
- (d): The guidelines regarding community based testing aim to supplement the existing facility based testing to increase the uptake of HIV testing services among the 'at risk' population which have been unreached so far. The cases detected as a result of the tests depend on the risk behavior of the population.
- (e): At present, out of the 21 lakh people estimate to be living with HIV, 16.2 Lakh are on record.

The steps taken to improve detection are:-

- 1. Community based testing for 'at risk' population.
- 2. Universal coverage of pregnant women for HIV testing to detect HIV Positive Pregnant Women and to eliminate mother to child transmission of HIV.
