STATEMENT REFERRED TO IN REPLY TO PARTS (a) AND (b) OF UNSTARRED QUESTION NO. 1909 BY SHRI GOPAL SHETTY TO BE ANSWERED IN LOK SABHA ON 07.03.2018 REGARDING DAMAGE OF RAILWAY TRACKS

(a): The number of incidents regarding damage of rail tracks by naxals and terrorist organisations reported over Indian Railways during the years 2015, 2016, 2017 and 2018 (upto January) is appended.

(b): Policing on Railways being a State subject, prevention of crime, registration of cases, their investigation and maintenance of law and order in Railway premises as well as on running trains and security of railway tracks, tunnels and bridges are the statutory responsibility of the State Governments, which they discharge through Government Railway Police (GRP)/District Police. However, Railway (RPF) Protection Force supplements the efforts of GRP by providing better protection and security of passengers & passenger area and for matters connected therewith. Proper coordination at all levels is being maintained by the Railways with the Ministry of Home Affairs (MHA), State Governments, Central/State Intelligence Agencies and State Police/GRP authorities for security of railway infrastructure including Railway track and stations over Indian Railways.
