### 4192. SHRI VIRENDER KASHYAP:

Will the Minister of COMMUNICATIONS be pleased to state:

- (a) whether Telecom Advisory Committee (TAC) meetings are held regularly at circle and Secondary Switching Area (SSA) levels in the country and if so, the details thereof, State/UT-wise and if not, the reasons therefor;
- (b) whether the suggestions made by Members of Parliament (MPs) and other members of the committee are not implemented, if so, the details thereof and the reasons therefor;
- (c) the current status of the meetings held at the circle level;
- (d) whether the MPs attend these meetings and if not, the steps taken by the Government to ensure their attendance; and
- (e) the decision taken by the Government to ensure attendance of MPs in all the SSAs of the Parliament Constituency of the said MPs?

#### **ANSWER**

## THE MINISTER OF STATE (IC) OF THE MINISTRY OF COMMUNICATIONS & MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI MANOJ SINHA)

- (a) Madam, Telephone Advisory Committees (TACs) are constituted at telecom district level and not at the circle level. TAC meetings are held regularly by BSNL and MTNL. The state-wise details of number of TAC meetings held at SSA level in BSNL and MTNL area are at **Annexure A** and **Annexure-B** respectively.
- (b) No Madam, the suggestions made by Hon'ble Members of Parliament (MPs) and other members of the Telephone Advisory Committees (TACs) are being implemented as per feasibility.
- (c) Madam, Telephone Advisory Committees (TACs) are constituted at telecom district level and not at the circle level. However, The state-wise details of number of TAC meetings held at SSA level in BSNL and MTNL area are at **Annexure A** and **Annexure-B** respectively.
- (d) & (e) Yes Madam, Hon'ble Members of Parliament (MPs) attend the TAC meetings. The dates of TAC meetings are decided by BSNL/MTNL in consultation with Hon'ble MPs to ensure their presence in the meetings
