Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) whether the performance of Indian Oil Corporation Limited (IOCL) has been the highest ever during the last three years particularly in 2016-17 in respect of all important physical parameters viz. Net Profit, Sales, Refinery Capacity Utilization and Pipeline Capacity Utilization, if so, the details thereof along with the figures for the last three years in this regard;
- (b) the details of the rating of IOCL during the last 10 years;
- (c) whether the Memorandum of Understanding rating of IOCL got downgraded due to adoption of the changed criteria adopted by DPE applicable with retrospective effect despite performance being the highest ever and if so, the details thereof;
- (d) whether other oil marketing companies i.e. HPCL, BPCL and GAIL had also similar performance on Additional Eligibility Criteria and change in the policy favoured these companies and disfavoured IOCL resulting in rating of IOCL getting downgraded whereas that of others remaining excellent and if so, the details thereof;
- (e) whether the Government has assessed the impact on the motivation level of employees of IOCL and also on productivity due to this arbitrary decision and if so, the details thereof; and
- (f) whether the Government proposes to review the said decision and correct the discriminatory order to upgrade the rating of IOCL and if so, the corrective steps taken in this regard?
