#### **Implementation of TEQIP**

#### 4990. SHRIMATI POONAMBEN MAADAM:

#### Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) whether the Government has received any proposal from the State Government of Gujarat under the Technical Education Quality Improvement Programme(TEQIP) being implemented with the assistance of the World Bank;
- (b) if so, the details of the proposal received during the last three years and the current year; and
- (c) the details of the decisions taken on the said proposals till date and the details of the programme approved location/ district-wise?

#### ANSWER

### MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DR. SATYA PAL SINGH)

(a) to (c): Yes Madam. The Technical Education Quality Improvement Programme (TEQIP) phase-III project funded by the World Bank, for improving the quality of technical education is being implemented in 19 educationally backward States with effect from April 2017 for 3 years. In addition, well performing TEQIP-I & II institutes from States other than 19 focus states, including from Gujarat, are also participating for mentoring purposes. Under this, the engineering colleges prepare Institution Development Proposals (IDPs), which are approved after due evaluation. So far, (10) IDPs have been received from Gujarat. Details of proposal are at Annexure.

As per the proposals submitted by 10 institutes (details at Annexure), only Birla Vishvakarma Mahavidyalaya (BVM), Vallabh Vidynagar met the eligibility requirements and got selected through challenge method for participation in TEQIP-III.
