PMAY IN SLUMS

No. 5066 DR. KRISHAN PRATAP:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) whether the Government has implemented the Prime Minister Awas Yojana (PMAY) in the scheduled or unscheduled slums and if so, the progress made in this regard, State-wise;
- (b) the number of people living in slums benefited under this scheme along with the number of people yet to be covered under the scheme;
- (c) the details of the budgetary allocation/funds released and spent on slum development schemes during the last three years and the current year, State-wise; and
- (d) the details of the mechanism to check the progress of these projects and misappropriation of funds?

ANSWER

- (a): The Government of India through Ministry of Housing and Urban Affairs (MoHUA) has launched the Pradhan Mantri Awas Yojana (Urban) {PMAY(U)} Mission on 25 June, 2015 in order to provide all weather pucca houses to all eligible homeless households across the urban

areas of the country including the scheduled or unscheduled slums. The State-wise progress of PMAY(U) is attached at Annexure-I.

- (b) & (c): Under 'In-situ' Slum Rehabilitation (ISSR) component of PMAY(U) mission there is a provision to provide all weather pucca house to all eligible urban slum homeless households. The State-wise progress of ISSR component of PMAY(U) along with the funds released during the last three years and the current year is attached at Annexure-II.
- (d): The PMAY(U) Mission Guidelines prescribe three-tier structure for effective monitoring and implementation of its various components as under:
- i. An Inter-Ministerial Committee viz. Central Sanctioning and Monitoring Committee (CSMC) constituted under the Chairpersonship of Secretary, Housing & Urban Affairs is an important decision making body responsible for overall review and monitoring of the Mission.
 - ii. A Committee of Secretary, MoHUA and Secretary, Department of Financial Services, Ministry of Finance has also been constituted for monitoring the Credit Linked Subsidy Scheme (CLSS) component of the Mission.
 - iii. An inter-departmental State Level Sanctioning & Monitoring Committee (SLSMC) headed by the Chief Secretary of the concerned State is in-charge of overall implementation and monitoring of the Mission at State level.
 - iv. A city level Mission envisaged under the Chairpersonship of the Mayor or Chairman of the Urban Local Body (ULB) monitors the implementation of the scheme in the selected cities.
