New Monitoring Format

5071. ADV. M. UDHAYAKUMAR:

Will the Minister of CHEMICALS AND FERTILIZERS be pleased to state:

- (a) whether the Government has come out with a new format to collect data to monitor the price movement of 19 medical devices;
- (b) if so, the details thereof;
- (c) whether a new format based on Form V prescribed under DPCO, 2013 has been prepared; and
- (d) if so, the details thereof?

ANSWER

(a) to (d): Yes, Madam. National Pharmaceutical Pricing Authority (NPPA) has developed a format based on Form-V prescribed under the Drugs (Prices Control) Order, 2013 (DPCO, 2013) for collecting data in respect of 19 medical devices notified as drugs under the Drugs and Cosmetics Act, 1940 and the Drugs and Cosmetics Rules, 1945 for monitoring purposes. The new format prepared by NPPA is placed at Annexure. This format has been developed in consultation with the Medical Device Industries and Associations, and uploaded on the website of NPPA www.nppaindia.nic.in on 12th May 2017.
