Will the Minister of HEAVY INDUSTRIES AND PUBLIC ENTERPRISES be pleased to state:

- (a) whether the Government has identified several cities in the country to introduce electric vehicles in the public transportation systems and if so, the details of such cities shortlisted;
- (b) whether the Government has received proposals from various State Governments including Kerala in response to the expression of interests invited by the Government;
- (c) if so, the details thereof;
- (d) whether this initiative is a part of the Electric Vehicle Mission 2030 policy; and
- (e) if so, the details thereof?

(a) to (c): To give a fresh thrust to e-mobility in public transport, an Expression of Interest (EoI), inviting proposals from million plus cities and special category states, for extending demand incentives for public & shared mobility based on electric powertrain was issued on 31st October 2017 under the FAME India Scheme. The details of the proposals received from various States, including Kerala, in response to the said EoI are annexed:-

After evaluation of these proposals, the competent committee based on determined selection criteria, selected the following cities for funding as per details given below:-
