PRODUCTION OF LIVESTOCK PRODUCTS

5267. SHRI KUNDARIYA MOHAN BHAI KALYANJI BHAI:

Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि और किसान कल्याण मंत्री be pleased to state:

- (a) whether the Government has made a survey about the production of livestock products in the country during the last one year;
- (b) if so, the details and the outcome thereof including the targets set and actual production, State-wise;
- (c) the steps being taken by the Government to improve quality of livestock and production of livestock products during the current year; and
- (d) the total revenue earned by the Government on livestock products?

ANSWER

THE MINISTER OF STATE AGRICULTURE AND FARMERS WELFARE (SHRIMAATI T KRISHNA RAJ)

- (a) Yes, the Government conducts Integrated Sample Survey in participation with the States/UTs every year to assess the production of livestock products. The latest period of the survey was March 2016 to February 2017.
- (b) As per the outcome of Integrated Sample Survey the State-wise estimated production of livestock products namely Milk, Egg, Meat and Wool during the year 2016-17 along with the targeted production for the year 2016-17 is placed as Annexure.
- (c) In order to complement and supplement the efforts made by the States for improving livestock and enhancing production and productivity, Government of India has been implementing following schemes/programs:
 - i) Rashtriya Gokul Mission
 - ii) National Programme for Bovine Breeding and Dairy Development (NPBBDD)
 - iii) National Dairy Plan-I
 - iv) Livestock Health and Disease Control
 - v) National Livestock Mission
 - vi) Government has also established three subordinate organizations namely, (a) Central Cattle Breeding Farms (CCBFs) (b) Central Herd registration Scheme and (c) Central Frozen Semen Production & Training Institute. These institutes playing crucial role in supply of high genetic merit bulls and semen doses of indigenous breeds.
- (d) Livestock products like Milk, Egg, Meat, Wool etc. attracted Nil rate of Central Excise duty. Hence, no revenue was collected in the last three financial years.
