PROCUREMENT OF URAD AND MOONG DAL AT MSP

547. SHRI OM BIRLA:

Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

- (a) the details of the quantum of 'urad' and 'moong' dal purchased by the Government at Minimum Support Price (MSP) during the current year in Rajasthan and other States;
- (b) the details of the procuring agency currently engaged by the Government in Rajasthan for purchasing and procurement of 'urad' and 'moong' dal along with total number of procurement centres established by the Government in the current year;
- (c) whether the Government has released and awarded the tender for carrying out the procurement activity of 'urad' and 'moong' dal in the State of Rajasthan, if so, the details thereof; and
- (d) whether the Government has established any qualification criteria for the selection of the surveyors engaged across various crop procurement centres, if so, the details thereof?

- (a): The details of the quantum of urad and moong purchased by the Government at Minimum Support Price (MSP) under Price Support Scheme (PSS) during the current year in Rajasthan and other States is placed at Annexure -I.
- (b): Currently, NAFED as Central Nodal agency and Rajasthan State Co-operative Marketing Federation Limited (RAJFED) as State Level Supporter, appointed by the State Government are engaged in procurement of urad and moong in the state of Rajasthan by opening 141 procurement centres in the state.
- (c): Based on the proposal received from Government of Rajasthan, Government has approved the procurement of 1,31,600 MT of urad and 2,74,000 MT of moong under Price Support Scheme in the state during the current Kharif season.
- (d): Surveyors under PSS operations are engaged by Central Nodal agency / State Level Supporter through reputed survey agencies at their own cost at the time of procurement.
