- (a) whether the Government is providing any financial and technological support to boost the production of fruits and vegetables in the country;
- (b) if so, the details thereof including the funds allocated, disbursed and expenditure incurred for the above purpose during the last two years and the current year, State-wise; and
- (c) the steps taken by the Government to provide adequate financial and technical support to improve the horticulture production including fruits?

(a) to (c): Mission for Integrated Development of Horticulture (MIDH), a centrally sponsored scheme is implemented for the holistic development of horticulture sector in the country covering fruits, vegetables, root and tuber crops, mushrooms, spices, flowers, aromatic plants, coconut, cashew, cocoa and bamboo through various interventions.

Under MIDH, for promotion of horticulture throughout the country, financial & technical assistance is provided to States/UTs for following major interventions/activities:

- Setting up of nurseries, tissue culture units for production of quality seed and planting material.
- Area expansion i.e. Establishment of new orchards and gardens for fruits, vegetables, and flowers.

- Rejuvenation of unproductive, old, and senile orchards.
- Protected cultivation, i.e. poly-house, green-house, etc, to improve the productivity & grow off season high value vegetables and flowers.
- Organic farming and certification.
- Creation of water resources structures and watershed management.
- Bee-keeping for pollination.
- Horticulture Mechanization.
- Creation of Post Harvest Management and Marketing infrastructure.
