- (a) the details of the empanelled public and private companies for crop insurance scheme in the country;
- (b) whether percentage share of Agriculture Insurance Company of India Limited has decreased substantially against the private companies under crop insurance scheme during each of the last three years and the current year; and
- (c) if so, the details thereof and the total number of farmers benefited under the above said scheme during the said period, State-wise?

(a): All the five Public Sector Insurance Companies namely, (i) Agriculture Insurance Company of India Limited, (ii) United India Insurance Company Limited, (iii) National Insurance Company Limited, (iv) Oriental Insurance Company Limited and (v) New India Assurance Company Limited are empanelled for crop insurance scheme in the country. In addition, 13 private sector general insurance companies namely, (i) ICICI-Lombard General Insurance Company Ltd. (ii) HDFC-ERGO General Insurance (iii) IFFCO-Tokio General Insurance Company Limited (iv) Company Limited. Cholamandalam MS General Insurance Company Limited, (v) Tata-AIG General Insurance Company Limited, (vi) Future Generali India Insurance Company Limited, (vii) Reliance General Insurance Company Limited, (viii) Bajaj Allianz General Insurance Company Limited., (ix) SBI General Insurance Company Limited, (x) Universal Sompo General Insurance Company Limited, (xi) Shriram General Insurance Co. Limited, (xii) Royal Sunaram General Insurance Company Limited and (xiii) Bharti Axa General Insurance Company Limited have also been empanelled for implementation of the scheme.

- (b): Percentage share of Agriculture Insurance Company of India Ltd. (AIC) on gross premium in the country was 56%, 63% and 36% during 2014-15, 2015-16 and 2016-17 respectively. However, share of all the Public Sector insurance companies including AIC during 2016-17 is more than 50%.
- (c): State-wise details of number of farmers insured and benefitted under the scheme during last three years i.e. 2014-15 to 2016-17 are given in **Annexure**.
