# GOVERNMENT OF INDIA MINISTRY OF DRINKING WATER & SANITATION LOK SABHA UNSTARRED QUESTION NO.946 TO BE ANSWERED ON 08.02.2018

#### **Drinking Water and Sanitation Projects**

#### 946. SHRI NISHIKANT DUBEY:

Will the Minister of DRINKINGWATER AND SANITATION be pleased to state:

- (a) whether the Government has allocated funds for the development of Sanitation and Drinking Water Projects in the country particularly for Jharkhand;
- (b) if so, the details thereof and the funds sanctioned during the last two years, yearwise and State-wise;
- (c) whether the Government has reviewed the ongoing projects in the country; and
- (d) if so, the outcome thereof?

### ANSWER

## MINISTER OF STATE FOR DRINKING WATER AND SANITATION (SHRI S.S.AHLUWALIA)

(a)& (b)Yes, Madam. The Central Government has allocated funds for drinking water and sanitation projects to States including Jharkhand. Under National Rural Drinking Water Programme (NRDWP), Rs 7050 crore has been allocated to the Ministry during 2017-18. Out of this, Rs. 149.72 crore has been allocated to the State of Jharkhand. The state-wise details of funds (including Jharkhand) sanctioned / released during the last two years is at Annexure-1.Under Swachh Bharat Mission (Gramin), State-wise and year-wise funds are not sanctioned. The State/UT-wise details of funds released to the State/UT-(Central share) under SBM (G) during last 2 years areat Annexure-II

(c) & (d) Yes Madam. Providing drinking water supply to the rural population is a dynamic and continuous process. Rural Water Supply being a state subject, implementing agencies are under State Government. This Ministry monitors the physical & financial progress of works through capturing the details in Integrated Management Information System (IMIS). The same is also reviewed in various meetings / visits / workshops by the Ministry. This Ministry has carried out a National Level workshop on restructuring of NRDWP, road map for HarGhar Jal and the best practices carried out in the states in rural water supply sector recently. The focus of the Ministry is on early completion of all ongoing projects so that its benefits accrue to the rural population expeditiously.

Ministry of Drinking Water and Sanitation regularly reviews the SBM(G) programme also. There is a spurt in the progress made under the programme. Since the launch of Swachh Bharat Mission (Gramin) on 2nd October, 2014, 611.01 lakh toilets have already been constructed under SBM(G) as on 05.02.2018. Sanitation Coverage, which was 38.7% on 2.10.2014, has increased to 77.52% on 05.02.2018. 312 Districts, 2803 Blocks, 1,39,386 GPs and 3,16,670 Villages have been declared Open Defecation Free (ODF) as on 05.02.2018. In addition, 11 States/UT namely Sikkim, Himachal Pradesh, Kerala, Uttarakhand, Haryana, Gujarat, Chandigarh, Daman and Diu, Arunachal Pradesh, Chhattisgarh and Meghalaya have also been declared ODF.
