Toilet Facilities

961. SHRI KALIKESH N. SINGH DEO:

Will the Minister of **DRINKING WATER AND SANITATION**be pleased to state:

- (a) the number and percentage ofhouseholds which have toilet facilities in the country, State/UT-wise;
- (b) the number of households and their percentage in the country including Odishawho practice open defecation, State/UTwise;
- (c) the steps taken by the Governmentto provide them toilet facilities and for safedisposal of solid and liquid waste; and
- (d) the steps taken to ensure watersupply in toilets, State/UT-wise?

ANSWER

MINISTER OF STATE FOR MINISTRY OF DRINKING WATER & SANITATION (SHRI RAMESH CHANDAPPA JIGAJINAGI)

- (a) State/UT-wise, number and percentage of Rural Households with access to toilets as on 06.02.2018 is at Annexure-1.
- (b) State/UT-wise, number and percentage of Rural Households practicing open defecation as on 06.02.2018 is at Annexure-2.
- (c) The Swachh Bharat Mission (Gramin) (SBM(G)) has been launched on 2nd October, 2014, which aims at attaining Swachh Bharat by 2nd October 2019. The focus of the scheme is on behavior change and usage of toilets. Under Swachh Bharat Mission (Gramin), there is a provision of an incentive of Rs. 12,000 for the construction of Individual household latrine (IHHL) to all Below Poverty Line (BPL) households and to identified Above Poverty Line (APL) households (all SCs /STs, small and marginal farmers, landless labourers with homestead, physically handicapped and women-headed households). Solid and Liquid Waste Management (SLWM) is one of the integral component of Swachh Bharat Mission (Gramin) and under this component, activities like compost pits, vermi composting, biogas plants, low cost drainage, soakage channels/ pits, reuse of waste water and system for collection, segregation and disposal of household garbage and menstrual hygiene management etc. can be taken up. Funds for Solid and Liquid Waste Management activities with cap of Rs. 7/12/15/20 lakh are available for Gram Panchayats having upto 150/300/500/ more than 500 households.
- (d) Under SBM-G, the incentive for individual toilet has been increased from Rs. 10,000 to Rs. 12,000, to provide for water availability, including for storing water for hand-washing and cleaning. The Swachh Bharat Mission (Gramin) and National Rural Drinking Water Programme(NRDWP) guidelines also provide for a conjoint approach in the implementation of the programmes of sanitation and water to maximize the availability of water for sanitation purposes. Open Defecation Free (ODF) declared villages are being prioritized for Piped Water Supply Schemes (PWSS) under NRDWP.
