(a) to (f): Ministry of Textiles has received following proposals from the various Implementing Agencies including the State Government of Maharashtra for promotion of Textiles, handlooms and handicrafts in Maharashtra in last three years under various Central Sector Schemes. Status of the proposals and scheme-wise release of funds to these projects during each of the last three years and the current year is given as under:-
