1666. SHRIMATI RITA TARAI:

Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state;

- (a) the number of Non-Governmental Organisations providing shelter facilities along with the number of juvenile inmates therein, State/UT-wise; and
- (b) whether there are reports of child abuse and non-availability of basic services as listed in the Juvenile Justice Act and if so, the details thereof along with the action taken in this regard?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF WOMEN AND CHILD DEVELOPMENT (DR. VIRENDRA KUMAR)

- (a): As per the information provided by the State/UT Governments, the number of Child Care Institutions (CCIs) registered under the Juvenile Justice (Care and Protection of Children) Act, 2000/2015 in the country alongwith the number of children residing in these institutions, supported under "Child Protection Services" (erstwhile Integrated Child Protection Scheme) under Umbrella Integrated Child Development Services, is at Annexure-I.
- (b): The National Commission for Protection of Child Rights (NCPCR) has reported that it has registered 43 complaints regarding child abuse and neglect of children in Child Care Institutions (CCIs) during the last three years and the current year 2018-19 (till June, 2018). Out of the 43 complaints, 38 have been closed and the remaining 5 cases are still pending. The State/UT-wise details are at **Annexure-II.**
