Conservation of Wild and Marine Animals

1694. COL. SONARAM CHOUDHARY:

Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) the mechanism in place for conservation of wild animals;
- (b) the amount spent on conservation, protection of wild life during the last three years, State/UT-wise;
- (c) whether there is any scheme to conserve wild and marine animals such as crocodiles, hippopotamus in the country including Rajasthan; and
- (d) if so, the details thereof?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT, FOREST AND CLIMATE CHANGE (DR. MAHESH SHARMA)

- (a) to (d) The Government has enacted a dedicated legislation for protection to wildlife, viz., the Wild Life (Protection) Act, 1972. The Act provides for the following important provisions for the purpose of conservation of wildlife:
 - (i) Creation of Protected Areas (National Parks, Wildlife Sanctuaries, Conservation Reserves and Community Reserves) for according better protection to wildlife and its habitats.
 - (ii) Appointment of officers like the Wildlife Wardens for implementing the provisions of the Act.
 - (iii) Creation of National Tiger Conservation Authority
 - (iv) Creation of Wildlife Crime Control Bureau
 - (v) Legal protection to species through listing them in various Schedules;
 - (vi) Stringent punishment for violation of provisions of the Act.
 - (vii)Constitution of Boards and Committees for advising the Central/State Governments on various matters pertaining to wildlife conservation.
 - (viii) Establishment of Authorities and Statutory Bodies

The Ministry of Environment, Forest and Climate Change provides financial assistance to the State/Union Territory Governments, including Rajasthan for conservation of wildlife and its habitat through Centrally Sponsored Schemes of 'Development of Wildlife Habitat (IDWH), 'Project Tiger' and 'Project Elephant'. The financial assistance provided to the State/Union Territory Governments during the last three years, under these schemes is as **Annexure-1A**, **Annexure-1B** and **Annexure 1 C** respectively.

Marine species and Crocodiles are also included under the Centrally Sponsored Schemes of 'Development of Wildlife Habitats' and 'Project Tiger'. However, Hippopotamus being an exotic animal, is permitted to be kept only in the Zoos of the country.
