1778. PROF. PREM SINGH CHANDUMAJRA:

Will the Minister of FINANCE be pleased to state:

- (a) whether the Government has launched the Pradhan Mantri Vaya Vandana Yojana (PMVVY):
- (b) if so, the details, salient features and the objectives thereof; and
- (c) the number of persons/senior citizens benefited under the scheme, State-wise including Punjab?

Answer Minister of State in the Ministry of Finance (Shri Shiv Pratap Shukla)

(a) and (b): Government has launched a scheme namely 'Pradhan Mantri Vaya Vandana Yojana' to protect elderly persons aged 60 years and above against a future fall in their interest income due to the uncertain market conditions, as also to provide social security during old age. The scheme is being implemented through Life Insurance Corporation of India (LIC) and provides an assured return of 8% per annum for 10 years. The differential return i.e. the difference between return generated by LIC and the assured return of 8% per annum is borne by Government of India as subsidy on annual basis. Mode of pension payment is monthly, quarterly, half-yearly and annually based on option exercised by the subscriber. The scheme was open initially for subscription for a period of one year i.e. from 4th May, 2017 to 3rd May, 2018. The minimum purchase price under the scheme was Rs.1.5 lakh per family for a minimum pension of Rs. 1,000/-per month and the maximum purchase price was Rs.7.5 lakh per family for a maximum pension of Rs.5,000/- per month.

In pursuance to Budget Announcement 2018-19, Pradhan Mantri Vaya Vandana Yojana has been extended up to 31st March, 2020 and the limit of maximum purchase price of Rs. 7.5 lakh per family under the scheme has also been enhanced to Rs 15 lakh per senior citizen.

(c): The state-wise number of senior citizens benefitted under the scheme, provided by LIC, is detailed at Annexure.
