# MINISTER OF STATE IN THE MINISTRY OF TRIBAL AFFAIRS (SHRI JASWANTSINH BHABHOR)

(a) & (b): The Ministry of Tribal Affairs had received proposals from the State Government of Maharashtra under the following schemes namely (i) Special Central Assistance to Tribal Sub Scheme (SCA to TSS), (ii) Grants under Article 275(1) of the Constitution (iii) Development of Particularly Vulnerable Tribal Groups (PVTGs), (iv) Post Matric Scholarship, (v) Mechanism for Marketing of Minor Forest Produce (MFP) through Minimum Support Price (MSP) and Development of Value Chain for MFP, (vi) Support to National / State Scheduled Tribes Finance and Development Corporations (NSTFDC/STFDCS) and (vii) Grants-in-aid to Voluntary Organisations working for the welfare of Scheduled Tribes and Strengthening Education among ST girls in Low Literacy Districts for the welfare of tribal people. Proposals from the State Governments are received and considered by the Ministry (by Project Appraisal Committee) for release of grant in accordance with the guidelines / norm stipulated under the schemes/ programmes. The details of proposals received, where available, and amount of money released during the last three years to State Government of Maharashtra under these schemes are given at Annexure-I (a to c).
