222. SHRI ABHISHEK SINGH:

Will the Minister of Electronics and Information Technology be pleased to state:

- (a) the State-wise details of the current status of Pradhanmantri Grameen Digital Saksharata Abhiyan(PMGDISHA);
- (b) the number of citizens registered till date under the said programme, State/UT-wise along with the number of citizens completed their training thereunder, State/UT-wise;
- (c) whether there are sufficient number of common service centres to provide digital training to the targeted citizens under the scheme and if so, the details thereof, State/UT-wise; and
- (d) the details of funds allocated and spent till date for the above project in the current financial year?

ANSWER

(a) and (b): Under Pradhan Mantri Gramin Digital Saksharta Abhiyan (PMGDISHA), as on 13.07.2018, a total of 1,23,72,067 citizens have been registered, out of this 1,23,60,855 citizens have completed the training. So far, a total of 64,41,313 citizens have been successfully certified under the Scheme. The State/UT-wise status is at **Annexure-I**.

(c): At present, 85,880 Common Service Centres(CSCs) and 38,258 other training centres are affiliated by the Implementing Agency of PMGDISHA (CSC e-Governance Services India Ltd.) for providing digital literacy training to the citizens. The State/UT-wise training centers/CSCs is at **Annexure-II**.

(d): For the current financial year, an amount of Rs. 400 crore has been allocated, out of which an amount of Rs. 200 crore has been released to the implementing agency.
