**Will the Minister of RAILWAYS be pleased to state:**

- (a) the details of the departure/ stoppage of Garib Rath (12535 and 12536), Puri-Valsad (22909 and 22910), Jammu Tawi (18215 and 18216) and Shalimar Bhuj Superfast Express (22829 and 22830) trains running in the country including Madhya Pradesh;**
- (b) whether these trains have stoppage in Umaria district of Madhya Pradesh and if not, the reasons therefor;**
- (c) whether the Government has received any proposal from Madhya Pradesh Government regarding stoppage of these trains in Umaria;**
- (d) if so, the details thereof along with the decision taken on the said proposal by the Government; and**
- (e) the time by which stoppage of above trains is likely to be provided at Umaria?**
