ASSESSMENT OF IT STARTUPS

2423 SHRI MULLAPPALLY RAMACHANDRAN:

Will the Minister of Electronics and Information Technology be pleased to state:

- (a) whether Government has made any assessment of IT start-ups in the country;
- (b) if so, the details thereof;
- (c) the state-wise number of successful IT start-ups in the country;
- (d) whether Government has made any assessment of employment generated by the IT start-ups in the country; and
- (e) if so, the details of the job created by these start-ups in the last four years; state-wise?

ANSWER

(a) and (b): There is no official assessment made by Ministry of Electronics and Information Technology (MeitY) specific to IT start-ups in the country. As per Nasscom-Zinnov report 2017, there has been an addition of 1000 tech start-ups in 2017 taking it to a total of 5200 tech start-ups. MeitY has been supporting incubation activities wherein at present 287 start-ups are being facilitated in ICT domain. Also, Department of Industrial Policy and Promotion (DIPP) has recognised 1,507 start-ups that provide IT services under Startup India initiative as on 28.07.2018.

(c): There is no data collected on state-wise number of successful IT start-ups in the country. However, State and UT wise recognised IT start-ups is at Annexure-1.

(d): Total employment generated and reported by IT services start-ups as per Startup India Programme is 18,470. Also, through an impact assessment report of MeitY supported incubation activities over a period of 5 years, 3188 jobs have been created across the country.

(e): Employment reported by IT services start-ups State and UT wise is at Annexure-2.
