Expenditure on National Parks

2797. SHRIMATI RITI PATHAK:

Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) the details of the expenditure incurred by the Union and State/UTs Governments on the conservation of National Parks during each of the last three years and the current year, State/UT-wise;
- (b) the revenue earned from national parks through tourism during the said period, State/UT and year-wise; and
- (c) the steps taken by the Government for increasing Tourism and conserve maintenance of national parks of the country?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT, FOREST AND CLIMATE CHANGE (DR. MAHESH SHARMA)

- (a) The details of financial assistance provided by the Ministry of Environment, Forest and Climate Change to State/Union Territories under the Centrally Sponsored Scheme of 'Integrated Development of Wildlife Habitats', which *inter-alia*, includes Development of Wildlife Habitats, Project Tiger and Project Elephant during the last three years, for conservation of National Parks and Sanctuaries is at **Annexure-1a**, **1b** and **1c**.
- (b) Management of National Parks including tourism activities is the mandate of the respective State/Union Territory Governments. The State/Union Territory wise details of revenue earned form National Parks through tourism is not collated at the level of Ministry of Environment, Forest and Climate Change.
- (c) The Ministry of Environment, Forest and Climate Change provides financial assistance to State/Union Territories under the Centrally Sponsored Scheme of 'Integrated Development of Wildlife Habitats', which *inter-alia*, includes Development of Wildlife Habitats, Project Tiger and Project Elephant, for protection and conservation of National Parks.

Concerned State/UT Governments prepare Management Plans which also incorporates tourism, ensuring better conservation and protection of National Parks. The National Tiger Conservation Authority has issued guidelines, namely, 'The National Tiger Conservation Authority (Normative Standards for Tourism activities and Project Tiger) Guideline, 2012' with respect to tourism.
