Will the Minister of FINANCE be pleased to state:

- (a) whether the Government is likely to extend the last date of 31st March, 2018 for seeding the Aadhaar with bank accounts;
- (b) if so, the last date prescribed by the Government in this regard; and
- (c) the total number of such account holders who have linked their bank accounts with the Aadhaar, State/UT, bankwise?

(a) & (b) As informed by Department of Revenue, Ministry of Finance, the Government has notified on 31.03.2018 that Central Government extended the date of submission of Aadhaar Number, and Permanent Account Number or Form 60 by the clients to the reporting entity till a date to be notified, subsequent to pronouncement of final judgement in WP.(C) 494/2012 etc. by Hon'ble Supreme Court.

(c) State/Union Territory-wise and bankwise number of Current and Savings account holders who have linked their bank accounts with the Aadhaar is at Annexure-I & Annexure-II.
