## MINISTER OF STATE FOR FINANCE (SHRI P. RADHAKRISHNAN)

(a) to (c): Only one project-Madhya Pradesh Irrigation Efficiency Improvement Project proposed by the State Government of Madhya Pradesh is pending with Ministry of Finance. The project worth USD 375 million has already been negotiated on 28<sup>th</sup> March, 2018 and has been approved by Asian Development Bank on 31<sup>st</sup> May, 2018. Loan signing is still pending as DEA has requested Govt. of Madhya Pradesh to furnish project readiness checklist which is still awaited. Sectoral project proposals are dealt by the respective Department/Ministry. Department of Expenditure does not have any project proposal pending for approval.
