- (a) whether the Agrias in Gujarat are involved in production of salt;
- (b) if so, the details thereof and the assistance provided to them by the Government; and
- (c) the steps taken by the Government to provide housing, electricity, water, education etc. to them?

#### **ANSWER**

- (a): Yes, Madam.
- (b) & (c): Approximately 45,000 Agrias are involved in the production of Salt in the State of Gujarat. The Government, through Salt Commissioner's Organization, conducts a number of activities for the welfare of salt workers. These include construction of labour rest sheds, organizing general medical health-cum-eye camps, training programmes, sports meet, financial assistance in the form of rewards to meritorious children of salt workers etc. The details regarding reward scheme for meritorious children of salt workers in Gujarat during last five years are at Annexure. Under the erstwhile Namak Mazdoor Awas Yojna (NMAY), 3058 houses were constructed for the Agrias engaged in salt production in the State of Gujarat, during 2003 to 2008.
