Will the Minister of Housing & Urban Affairs be pleased to state:-

- (a) the details of the major schemes of his Ministry aimed at addressing the ever growing urban poverty in the country;
- (b) the details of funds allocated to address the urban poverty across the country along with the funds utilized/ unutilized during each of the last three years and the current year, State-wise;
- (c) the reasons for unspent allocations during the said period;
- (d) the action initiated against those States which have failed to spend the allocations during this period; and
- (e) the other steps taken by the Government to eradicate urban poverty in the country?

- (a) This Ministry is implementing "Deendayal Antyodaya Yojana- National Urban Livelihoods Mission (DAY-NULM)" to reduce poverty and vulnerability of urban poor households.
- (b) & (c) A statement showing State-wise details of funds released & utilized during 2015-16 to 2018-19 and unutilized funds available with States/UTs as on July 31, 2018 under Mission is at Annexure. During the

initial years the States/UTs had the balance of funds from erstwhile SJSRY and they were in the process of putting in place the requisite institutional step up for implementation of the Mission. The pace of implementation has now picked up and the quantum of unspent balance with States/UTs has come down drastically.

- (d) & (e) The Ministry is regularly monitoring implementation of the Mission, including utilization of funds, in all the States/UTs through meetings, video conferences, field visits and correspondences.
