**3762. SHRI M.B. RAJESH:**

Will the Minister of **DRINKING WATER AND SANITATION** be pleased to state:

- (a) the Budgetary allocation and actual spending on Swachh Bharat Mission (SBM) for each year ever since the programme has been announced;
- (b) the targets fixed for each year and physical achievement made under the Mission;
- (c) the State-wise break up of construction of toilets since the launch of the SBM; and
- (d) the details of States and Union Territories already declared Open Defecation Free (ODF)?

- (a) Budgetary allocation and actual expenditure on Swachh Bharat Mission (Gramin) [SBM(G)] since 2014-15, year-wise, are as under:-
