# STATUS OF RURAL ROAD PROJECTS UNDER PMGSY

## 3769. SHRI M. MURALI MOHAN:

Will the Minister of **RURAL DEVELOPMENT** be pleased to state:

- (a) the details of roads constructed in kilometres under Pradhan Mantri Gram Sadak Yojana (PMGSY), State/UT-wise;
- (b) the quantum of funds sanctioned and released for the projects there under along with the status of their completion;
- (c) whether roads being planned/ approved/under consideration for the upcoming projects in the States; and
- (d) if so, the details thereof and if not, the reasons therefor, State/UT-wise?

# ANSWER MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI RAM KRIPAL YADAV)

(a) & (b): 'Rural Roads' is a State subject and Pradhan Mantri Gram Sadak Yojana (PMGSY) is a one-time special intervention to provide rural connectivity, by way of a single allweather road, to the eligible unconnected habitations in the core network. The details of roads constructed under PMGSY, State/UT-wise are given in Annexure – I. Since inception till June, 2018, 6, 65,737.94 Km road length has been sanctioned, out of which 5,56,389.37 Km has been completed by incurring an expenditure of Rs. 183,095.37 crore as per the details given in Annexure-II.

(c) & (d): As on  $2^{nd}$  August, 2018, 1528 road works submitted by various States are under consideration of the Ministry as per details indicated in Annexure-III.
