Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

(a) whether the Government has made any assessment to ascertain the number of people suffering from various diseases including communicable and noncommunicable diseases;

(b) if so, the details along with the outcome thereof, State/UT-wise;

(c) the schemes proposed or being run by Government to control such diseases including communicable and noncommunicable diseases in the country;

(d) whether funds allocated under the schemes to control various diseases have been fully and properly utilised by State Governments; and

(e) if so, the details thereof for the last three years and if not, the corrective measures taken by the Government in this regard?

ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI ASHWINI KUMAR CHOUBEY)

(a) & (b): As per Report titled "India: Health of the Nation's States - The India State-Level Disease Burden Initiative" by Indian Council of Medical Research, Department of Health Research, Public Health Foundation of India and Institute for Health Metrics and Evaluation, Non Communicable Diseases contributes to 61.8% and Communicable, maternal, neonatal and nutritional diseases contributes to 27.5 of deaths to the total death in India. (c): Public Health and Hospitals is a State subject.
