#### **POCSO E-BOX**

#### 3960. SHRI SANKAR PRASAD DATTA:

Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) the number of complaints received so far through Protection of Children from Sexual Offences POCSO e-Box during each of the last three years and the current year, State/UT-wise;
- (b) whether the Government has reviewed the response to POCSO e-Box since its launch;
- (c) if so, the details and the outcome thereof;
- (d) whether the Government has also reviewed the action taken on these complaints in a timely manner; and
- (e) if so, the details thereof?

#### **ANSWER**

## MINISTER OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI MANEKA SANJAY GANDHI)

- (a) The National Commission for Protection of Child Rights (NCPCR) has received 2257 hits through Protection of Children from Sexual Offences (POCSO) e-Box since its inception, i.e., 26th August, 2016 till 27th July, 2018. Out of 2257 hits, 97 complaints have been found relating to child sexual abuse. The State/UT-wise details are given in *Annexure-I*.
- (b) to (e): Under Section 44 of POCSO Act, 2012 NCPCR and State Commission for Protection of Child Rights(SCPCR) are mandated to monitor the implementation of provision of POCSO Act, 2012. The POCSO e-Box functions under the supervision of Member, NCPCR who reviews progress weekly for timely action, due to which 63 out of 97 cases have been disposed off.
