- (a) the extant provisions to penalise the companies and contractors failing to ensure the quality of railway bridges and maintain them in proper condition for a long time;**
- (b) the number of companies and contractors against whom action has been taken so far for the violation of the said provisions;**
- (c) the names and details of companies and contractors black listed out of the above; and**
- (d) the rules for putting the names of contractors in the black list?**

STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (d) OF STARRED QUESTION NO. 213 BY SHRI LAXMI NARAYAN YADAV AND SHRI HARISHCHANDRA CHAVAN TO BE ANSWERED IN LOK SABHA ON 26.12.2018 REGARDING QUALITY OF RAILWAY BRIDGES

(a): As per Clause 22(1) of Indian Railway General Conditions of Contract, November 2018 (GCC), which is a part of works contract over Indian Railways, contractor is required to execute works in conformity with the specifications and drawings of the contract failing which, payment is not released in terms of Clause 46 (1) & 51 (1) of the above GCC. Details of above is available at Indian Railways' website, www.indianrailways.gov.in at link http://www.indianrailways.gov.in/railwayboard/uploads/directorate/civil_engg/pdf/IR%20GCC%20November%202018_R.pdf Further, railway retains 5% of the contract value as Security Deposit and is released only after maintenance of the work for maintenance period, failing which the Security Deposit is forfeited.

(b) & (c): Railway does not maintain the list of contractors against whom action has been taken for violation of above. However, a list of such 42 Civil Works contractors, against whom the business has been banned for a fixed period, is placed at Appendix-I.
