- (a) the details of the national highway projects pending for environmental clearance during the last three years and the current year, State/UT-wise;
- (b) the reasons therefor along with the details of cost escalation in these projects;
- (c) whether the National Highways Authority of India (NHAI) proposes compensation for the said projects under public private partnership and if so, the details thereof, State/UT-wise including Uttar Pradesh; and
- (d) the length of national highways in kilometres where work has been completed during the last three years and the current year along with the details thereof?

**(a) to (d):** There are six National Highways (NHs) projects pending due to environment clearance, details are given at Annexure-I. As Environmental Clearance (EC) is obtained prior to Appointed Date, the question of cost escalation due to EC does not arise. However, there is an inbuilt provision in the contract to provide cost escalation in Hybrid Annuity Model (HAM) and Engineering Procurement and Construction (EPC) projects when the delay is attributable to the Authority. In Public Private Partnership (PPP) projects, there is no provision of cost escalation. The Concessionaire are expected to complete the project in the given time frame.
