SKILL DEVELOPMENT TRAINING IN ITIS

2118. SHRI GODSE HEMANT TUKARAM:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- (a) whether the Ministry has opened new areas of Skill Development training in addition to the traditional occupational training available to the ITIs throughout the country;
- (b) if so, the details thereof;
- (c) whether the Ministry is extending its assistance to the State ITIs in terms of technical experts (Trainees), machinery, funds etc.; and
- (d) if so, the details thereof?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP (SHRI ANANTKUMAR HEGDE)

- (a) & (b) Directorate General of Training, Ministry of Skill Development & Entrepreneurship has signed MoUs with the following technological companies for imparting digital skills to the youth in addition to the traditional occupational training.
- 1. **MoU** with National Association of Software Services Companies (NASSCOM): An MoU has signed between Directorate General of Training, M/o Skill Development & Entrepreneurship and National Association of Software Services Companies (NASSCOM) on 27th April, 2018. NASSCOM is now advising DGT on future of jobs in IT-ITES sector. Some areas identified by NASSCOM for introduction of training programme in ITIs, to address the futuristic need of the Industry (Industry 4.0).

Following new trades have been introduced (as per MoU with NASSCOM) under CTS from the session started August, 2018.

- **2. MoU with IBM India Private Ltd:** Introduction of two year Advanced Technical Diploma in collaboration with IBM, for ITI pass outs in Central Institutes under DGT in the field of 'IT, Networking and Cloud Computing'.
- 3. MoU with SAP India Private Limited: An MoU has been signed between DGT, MSDE and SAP India Private Limited on 13th July, 2018 for skill development of Youth on Enterprise Software and Data Sciences. Under the MoU, the training will be run on cloud

based infrastructure and the Ministry and/or designated organizations would be required to provide/procure the cloud infrastructure.

In addition to, following 7 new trades have been introduced under Craftsmen Training Scheme from year 2018-19.

- (c) & (d) Directorate General of Training, Ministry of Skill Development & Entrepreneurship has formulated following schemes to fund ITIs in various States for Skill Development:
- 1. Enhancing Skill Development Infrastructure in North Eastern States and Sikkim: The scheme inter-alia envisages upgradation of 22 existing ITIs by establishment of 3 new trades in each ITI; supplementing deficient infrastructure in 28 ITIs by constructing new boundary wall, new hostel along with supplementing old and obsolete tools and equipment for 3 existing trades in each ITI. The details of coverage and fund released are at Annexed.
- 2. Upgradation of existing Government ITIs into Model ITIs: Existing ITI in the State has been taken for Upgradation into Model ITI which is supposed to evolve as an institution showcasing best practices, efficient and high quality training delivery and sustainable as well as effective industry relationship. The Institute Management Committee (IMC) society for each ITI with chairperson from Industry is empowered to implement the scheme at ITI level. All major trades are covered by the representatives of industries in IMC. The details of fund release are at **Annexed**.
- 3. Skills Strengthening for Industrial Value Enhancement (STRIVE): The Ministry is extending its assistance to the State ITIs by provisioning of funds under project STRIVE (Skills Strengthening for Industrial Value Enhancement), for technical experts, machinery etc. STRIVE is world Bank assisted scheme that envisages improving relevance and efficiency of skill development provided through ITIs and apprenticeship.

The scheme also covers inclusion of new trades in 500 ITIs across the country, as identified by the industry led Institute Management committee of that ITI.
