SKILL DEVELOPMENT TRAINING IN AGRICULTURE

2149. SHRIMATI KAMLA DEVI PAATLE:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- (a) the State-wise details of the schemes/programmes being implemented for Skill Development and training in agriculture and related fields for the farmers in various States including Chhattisgarh in each of the last three years and in the current year;
- (b) the number of farmers that have been imparted training under the schemes and the State/scheme-wise details of benefits accrued to them during the said period;
- (c) whether the Government has fixed any amount for this purpose under various schemes; and
- (d) if so, the State/scheme-wise details of the amount allocated and spent during the said period?

(a) to (d) There are various schemes of the government which provide training in agriculture and related fields to the farmers. Department of Agriculture Cooperation & Farmers Welfare (DAC&FW) is implementing a Centrally Sponsored Scheme on 'Support to State Extension Programs for Extension Reforms' popularly known as ATMA Scheme since 2005 in 76 districts of 29 states & 3 UTs of the country including all the districts of Chhattisgarh. The scheme promotes decentralized farmer-friendly system in the country. Under the scheme Grants-in-Aid is released to the State Governments in the ratio of 60:40 (Centre:State) to General States, 90:10 for North-Eastern & 3 Himalayan States and 100% for UTs with an objective to support State Government's efforts to revitalize the extension system and making available the latest agricultural technologies and good agricultural practices in different thematic areas of agriculture and allied. The extension activities include Farmers Training, Demonstrations, Exposure Visits, Kisan Mela, Mobilization of Farmers Groups and organizing Farm Schools etc. State-wise and year-wise Physical (farmers training) and financial achievements under the Extension Reforms (ATMA) Scheme are enclosed at **Annexure-I** and **Annexure-II** respectively.

Further, budget provision has been made under Rashtriya Krishi Vikas Yojana (RKVY) from 2016-17 to operationalize skill training courses through National Training Institutes, State Level Training Institutes (SAMETIs), Krishi Vigyan Kendras and State Agricultural Universities. The funds are released to the identified training institutes based on the proposals received in the Department. A total of Rs. 3.52 Crore, Rs. 2 Crore, Rs.15.46 Crore

have been allocated under RKVY during 2016-17, 2017-18 and 2018-19 (till date) respectively. State-wise details of candidates trained in the country including Chhattisgarh during last three years are at **Annexure III**.

The Ministry of Skill Development and Entrepreneurship is implementing flagship scheme of Pradhan Mantri Kaushal Vikas Yojana (PMKVY), launched in 2015, on pan India basis including the state of Chhattisgarh. Under PMKVY, training is provided in agriculture and related fields in the form of both fresh training as well as recognition of prior learning (RPL). Owing to success of PMKVY 1.0, Government modified its guidelines for 4 years (2016-20) to make it more effective, transparent and beneficiary oriented. Training in this sector is facilitated by Agriculture Skill Council of India (ASCI). A total of Rs. 1.55 Crore were released to ASCI in 2014-15. ASCI trained a total of 160871 in 2015-16 out of which 750 candidates were trained in Chhattisgarh. Under PMKVY 2.0 (2016-20), ASCI has so far trained 76215 candidates under various components of the scheme out of which 675 were trained in Chhattisgarh. In addition, 106117 candidates have been oriented in RPL under PMKVY 2.0.
