### PROMOTION OF STARTUPS

#### 2194. DR. KULAMANI SAMAL:

Will the Minister of **COMMERCE AND INDUSTRY** be pleased to state: वाणिज्य एवं उदयोग मंत्री

- (a) whether the Government has recently called on firms of foreign countries like the United States, China, Japan, Hong Kong, Singapore to attract foreign capital for the largest startup base in the country and if so, the details thereof along with its key objectives;
- (b) the details of the States wherein these startups are to come up, State-wise including Odisha;
- (c) the details of the startups established in different States along with the employment generated therefrom during each of the year since 2014-15, State-wise; and
- (d) the steps taken by the Government to ensure even employment opportunities are generated across all States in this regard?

#### **ANSWER**

### वाणिज्य एवं उद्योग मंत्रालय में राज्यमंत्री (श्री सी.आर. चौधरी) THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE & INDUSTRY (SHRI C.R. CHAUDHARY)

- (a): Startup India Global Venture Capital Summit 2018 was held on 7<sup>th</sup> December 2018 in Goa. It was a unique gathering of Global Fund Managers, Limited Partners, Officials from the Government of India and path-breaking startups. The dialogue focused on the huge return-generating potential of India's vast and diverse market monetized through cutting-edge technologies supported by investor-friendly regulations. The country-wise numbers of Venture Capital funds who participated in the event is present at annexure I.
- **(b):** There is no specific plan for establishment of Startups across the country under Startup India initiative.
- (c): 14,565 startups operating out of 35 States and Union Territories have been recognized under Startup India initiative as on 11.12.2018. Of these, 12,723 startups have self-declared employment information. The state-wise number of recognized startups and employment generated based on self-declared information by startups is present at annexure II. The year wise employment data is not centrally compiled.
- (d): No steps are envisaged for ensuring even employment generation across all States under Startup India initiative.
