Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) the details of objectives and norms laid down for establishing Kendriya Vidyalayas and Jawahar Navodaya Vidyalayas in the country;
- (b) whether the Government has received any proposals/ requests from any State Governments including Andhra Pradesh to open new Kendriya Vidyalayas and Jawahar Navodaya Vidyalayas in respective States and if so, the details thereof and the Government's response thereto;
- (c) whether the Government proposes to increase the number of such Vidyalayas in future in all the States including Madhya Pradesh and Gujarat and if so, the details thereof, State and location-wise; and
- (d) if not, the reasons therefor?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DR. SATYA PAL SINGH)

(a) Kendriya Vidyalayas (KVs) are opened primarily to cater to the educational needs of the children of transferable Central Government Employees including Defence & Para-Military personnel by providing a common programme of education. Proposals for opening of new KVs are considered only if sponsored by Ministries or Departments of the Government of India/State Governments / Union Territories Administrations thereby committing resources for setting up a new KV as well as the availability of necessary sanction of the Government.

The objectives of the Navodaya Vidyalaya (NV) are mainly to provide good quality modern education including a strong component of culture, inculcation of values, awareness of the environment, adventure activities and physical education to the talented children predominantly from the rural areas without regard to their family's socio-economic condition.

The norms prescribed for opening of Kendriya Vidyalayas in the Civil / Defence Sector are as under:

• Requirement of land:

- Sponsoring authority to provide independent rent-free temporary accommodation of about 15 rooms (size 7m x 7m) till the permanent Vidyalaya building is constructed by KVS.
- Sponsoring authority to provide residential accommodation for at least 50% of staff posted in the proposed Vidyalaya.
- Concentration of at least 500 employees of Defence /Central Govt./PSUs individually or jointly at the station.
- Availability of minimum 200 students of the priority categories for enrolment in the proposed KV.
- (b) to (d) As regards opening of new KVs, the Kendriya Vidyalaya Sangathan has informed that it has received 147 proposals / requests from various States/UTs for opening of new KVs including 14 proposals from Andhra Pradesh. The details are annexed. Final decision regarding setting up of the KV would depend upon the feasibility report, qualifying under the 'Challenge Mode' and approval of the competent authority.

As regards NVs, the Scheme provides for opening of one Jawahar Navodaya Vidyalaya (JNV) in each district of the country. Sanctioning of JNVs depends on the willingness of the State Government / UT Administration to make available requisite suitable land free of cost and making available required temporary accommodation free of rent to run the Vidyalaya till the permanent building is constructed. However, actual sanction and opening of new JNVs depends on availability of funds and approval by the competent authority. Opening of new JNVs is a continuous process and one JNV each has already been sanctioned in all the districts of the country (as on 31.5.2014).
