Water Budget

2600. SHRI KUNDARIYA MOHAN BHAI KALYANJI BHAI:

Will the Minister of DRINKING WATER AND SANITATION be pleased to state:

- (a) the percentage of water budget spent on improving the irrigation, drinking water facilities and reservoir capacity during each of the last four years, State/UT-wise;
- (b) the percentage of Gross Domestic Product spent on improving the irrigation, drinking water facilities and reservoir capacity during the said period, State/UT-wise;
- (c) the percentage of population having access to in-home tapped drinking water, State/UT-wise;
- (d) the gap between the demand for water for farming through irrigation and supply irrigation potential in the country, State/UT-wise; and
- (e) the steps taken by the Government to improve availability of water in drought prone areas and areas of water scarcity since 2014, State and year-wise ?

ANSWER

MINISTER OF STATE FOR DRINKING WATER AND SANITATION

- (a) to (e) As far as irrigation and reservoir capacity are concerned, the same is the mandate of Ministry of Water Resources, River Development and Ganga Rejuvenation (MoWR, RD & GR). As per information received from them, water resources development projects are planned and implemented by the state governments from their own resources. In order to supplement their efforts, Government of India (GOI) provides technical and financial assistance to State Governments to encourage sustainable development and efficient management of water resources through various schemes and programmes such as Accelerated Irrigation Benefits Programme (AIBP) etc. under Pradhan MantriKrishiSinchayeeYojana (PMKSY). Major/Medium Irrigation (MMI) projects generally have provisions for drinking water depending upon requirements. Further, as per information received from Ministry of Water Resources, River Development and Ganga Rejuvenation, 99 ongoing Major-Medium Irrigation (MMI) projects (including 59 projects benefitting drought areas) of various states under Pradhan MantriKrishiSinchayeeYojana – Accelerated Irrigation Benefit Programme (PMKSY-AIBP) have been prioritized during 2016-17 for completion by Dec, 2019.

Funding arrangement for the central and state share of these projects has been made through National Bank for Agriculture and Rural Development (NABARD). Further, Central Assistance (CA) is also being provided for Polavaram Project (National Project) of Andhra Pradesh and special package for Maharashtra for projects benefitting drought prone areas which also includes 8 MMI projects. The Polavaram project and schemes under special package are planned to be completed by Dec., 2019 and 2022-23 respectively. State-wise details of the above projects and CA released for these projects is at **Annexure-I**.

As far as drinking water facilities are concerned it is stated that this Ministry is responsible for rural areas. However, it is a state subject. This Ministry provides financial and technical assistance to State government for improving the coverage of safe drinking water in rural areas. State Governments are responsible of planning, designing and execution of drinking water supply schemes as well as management of all contracts / schemes. The State-wise details of the funds released to States/ UTs under National Rural Drinking Water Programme (NRDWP) during last four years are at **Annexure-II**. The percentage of Gross Domestic Product(GDP) spent on improving drinking water during the last 4 year is as under:

The Ministry maintains the coverage of in-home tapped drinking water in terms of Individual households and not in terms of population. As per information reported by States on the online portal Integrated Management Information System (IMIS) of the Ministry, State wise details of percentage of total household connections with Piped Water Supply (PWS) are at **Annexure-III**. To take relief measures for restoration of the drinking water supply in drought affected areas(Natural Calamity), States may utilize up to 25% of NRDWP funds as Flexi funds.
