Details are enclosed at Annexure. NHAI has received Rs. 9681.5 crores towards bid concession fee for TOT Bundle-1.

- (d) Bid for second Bundle of 7 projects under TOT has been invited with IECV (Initial Estimated Concession Value) of Rs. 5,362 crores on 06.08.2018 with Bid due date of 19.12.2018. Three bids have been received as on bid due date.
- (e) In TOT Model, Concessionaire provides upfront payment to Government which can be used for development of National Highways in future.
