†2933. SHRI HARI MANJHI:

Will the Minister of FINANCE be pleased to state:-

- (a) whether the States have benefited from increase in their share in tax revenue;
- (b) if so, the details thereof, State/UT-wise;
- (c) the details of the quantum of revenue provided to Jharkhand and other States in the country, State/UT-wise; and
- (d) whether the funds to be provided to District Council Members/Block Development Committee Members have been discontinued in the report of the Fourteenth Finance Commission and if so, the details thereof along with the reasons therefor?

ANSWER

MINISTER OF STATE FOR FINANCE (SHRI P. RADHAKRISHNAN)

- (a) to (c): Yes, the States have benefitted from an increase in their share in the divisible pool of Central taxes and duties. The share of the States in the divisible pool of taxes and duties has been enhanced from 32% to 42% as recommended by the 14th Finance Commission (FFC) for its award period (2015-20). The State-wise details of the aggregate tax devolution from the shareable pool of Central taxes and duties to the States including the State of Jharkhand for the award periods of 13th Finance Commission (TFC) and FFC (up to 2017-18) are provided in Annexure.
- (d): Yes. FFC vide Para 9.72 recommended that 'The grants that we recommend should go to gram panchayats, which are directly responsible for the delivery of basic services, without any share for other levels. We expect that the State Governments will take care of the needs of other levels'.
