4410. SHRIMATI RAKSHATAI KHADSE:

Will the Minister of CHEMICALS AND FERTILIZERS be pleased to state:

(a) whether the Government has conducted a survey for Spurious and Non-Standard Quality Drugs (NSQ);

(b) if so, the details thereof;

(c) the details of the agencies or organizations involved in this survey;

(d) the total expenditure incurred for the survey against the budgetary provision made; and

(e) the details of the outcome of the survey?

<u>ANSWER</u>

MINISTER OF STATE IN THE MINISTRY OF ROAD TRANSPORT AND HIGHWAYS; MINISTRY OF SHIPPING AND MINISTRY OF CHEMICALS AND FERTILIZERS (SHRI MANSUKH L. MANDAVIYA)

(a) & (b): Yes Madam, a nation-wide survey (2014-16) was conducted to assess the extent of Not of Standard Quality (NSQ)/Spurious drugs. Out of a total 47012 drug samples drawn from both Governments and private sources, the estimated percentage of NSQ and spurious drugs was found to be 3.16% and 0.0245% respectively.

(c): The survey was undertaken by National Institute of Biologicals (NIB). The details of the agencies or organizations involved in this survey are as follow:

- 2. National Institute of Biologicals (NIB), NOIDA
- 3. Central Drugs Standard Control Organization (CDSCO)

(d): The Ministry of Health & Family Welfare had approved this survey in the country at an estimated cost of Rs. 8.5 Crore. Expenditure incurred was Rs. 7.06 Crore.

(e): The estimated percentage of NSQ and spurious drugs in the nation-wide survey was found to be 3.16% and 0.0245% respectively. In the survey report, various recommendations for the role and responsibility of the various Stakeholders in addressing the problems of Spurious and NSQ Drugs in the country have been made.
