- (a) The details of projects implemented and financed by the National Capital Region Planning Board (NCRPB) along with the amount of loan assistance provided to each project during each of the last three years and the current year, State/ city-wise;
- (b) The details of the achievements made by NCRPB in this regard during the said period along with the details of utilization of loan assistance by the State Governments/ implementing agencies during the said period;
- (c) Whether the Board has identified any areas of weakness/ bottlenecks in bringing about development in the cities under the National Capital Region;

- (d) If so, the details thereof along with the corrective measures taken/ to be taken by NCRPB in this regard; and
- (e) Whether there is shortage of staff which is adversely affecting the functioning of the NCRPB and if so, the details thereof and the action taken/ being taken by the Government in this regard?

## **ANSWER**

# THE MINISTER OF STATE (INDEPENDENT CHARGE) OF THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI HARDEEP SINGH PURI)

(a) & (b) National Capital Region Planning Board (NCRPB) has informed that it does not administer/implement any project/scheme but only provides loan based financial support for the projects of the NCR participating States and their implementing agencies.

The details of the projects financed during the last three years and the current year, State and city-wise are available at NCRPB's website at <a href="http://ncrpb.nic.in/status.html">http://ncrpb.nic.in/status.html</a>

NCRPB provides financial assistance to participating States and for various projects like Water Supply, Sewerage, Sanitation, Drainage, Solid Waste Management, Roads, ROB's Flyovers, Power Sector, etc. These projects usually have long gestation period with loan repayment/agreement varying from 10-20 years. NCRPB has no case of default in repayment of loans by the participating States.

NCRPB is rated 'AAA' with stable outlook by CRISIL & ICRA which is the highest rating provided by them. It has no Non-Performing Assets (NPA) as on 30.11.2018.

(c)& (d) NCRPB has identified issues related to various sectors in the Regional Plan-2021 for namely, Transport, Power, Water, Solid Waste Sewerage, Management, Drainage, etc. The Regional Plan has suggested corrective measures/ strategies alongwith policies and proposals.
