(a) to (c):The status of fund approved and the progress of work in Sonepat District in Haryana under Centrally Sponsored Scheme of National AYUSH Mission (NAM) is furnished at **Annexure.** Further, under NAM, in the State of Bihar Ministry of AYUSH has sanctioned Rs. 22.71 Crore for supply of essential drug in 1384 AYUSH Dispensaries/Additional Primary Health Centres including the facilities of Darbhanga District. However State Government has not reported the expenditure of this amount. Further, no fund has been approved under the said scheme for the purpose of civil works in Darbhanga District.
