HEALTHCARE INFRASTRUCTURE DEVELOPMENT UNDER NHM

1103. SHRIMATI P.K. SREEMATHI TEACHER:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

(a) the details of districts identified in Kerala as the High Priority Districts for developing healthcare infrastructure;

(b) if so, the measures taken by the Government under NHM to strengthen the healthcare infrastructure in Kerala;

(c) the details of funds allocated, sanctioned, released and spent on healthcare infrastructure in Kerala and physical targets set and achieved so far; and

(d) the details of districts identified for the purpose in Kerala and status of each district?

ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI ASHWINI KUMAR CHOUBEY)

(a) to (d): Kasaragode, Malappuram, Alappuzha & Wayanad Districts of Kerala have been identified as High Priority Districts (HPDs) in Kerala. District-wise detail of healthcare status is not maintained centrally. However, as per the information received from the State Government of Kerala, General Profile of HPDs of Kerala is at Annexure-I.

Under National Health Mission (NHM), Government of India supports the States/ UTs for strengthening of their healthcare system including healthcare infrastructure on the basis of proposals received from them in their Programme Implementation Plans.

Under NHM, HPDs receive higher per capita funding as compared to other districts, enhanced monitoring, focussed supportive supervision and are encouraged to adopt innovative approaches to address their peculiar health challenges

In order to expand access to Comprehensive Primary Health Care (CPHC), under Ayushman Bharat, Sub Health Centres (SHCs) and Primary Health Centres (PHCs) are being strengthened as Health and Wellness Centres (HWCs). In the current FY for the State of Kerala, approval has been accorded for 671 HWCs.

The details of approval & expenditure under NHM for Kerala under Hospital Strengthening and New Constructions/ Renovation and Setting up for the F.Y. 2015-16 to 2018-19 is at Annexure-II.
