**PUBLIC PROCUREMENT POLICY**

Will the Minister of Micro, Small and Medium Enterprises be pleased to state:

- (a) the details of the status of the portal that would sanction loans of upto Rs 1 crore to small and medium enterprises in 59 minutes;
- (b) whether there is a provision of ensuring at least 4 per cent of the total procurement done by ministries, departments and Central Public Sector Enterprises (CPSEs) from the entities owned by SC/ST under the Public Procurement Policy (PPP) and if so, the details thereof including value of procurement made by the public sector enterprises during each of the last four years;
- (c) whether there is a provision of ensuring at least 3 per cent of the total procurement done by ministries, departments and Central Public Sector Enterprises (CPSEs) from the entities owned or run by women under the said policy and if so, the details thereof;
- (d) the corrective steps taken by the Government to ensure its strict implementation; and
- (e) whether the Government is considering any special provisions for the MSMEs owned / run by women in the country and if so, the details thereof?

(a): A portal has been launched to facilitate in-principle approval of MSME loans up to Rupees 1 crore by Public Sector Banks (PSBs).

(b): As per information furnished by the Department of Public Enterprises (DPE) for the year 2015-16 & 2016-17 and the information uploaded on Sambandh portal for subsequent years till 5<sup>th</sup> February, 2019, the details of annual procurement of goods & services from MSEs including SC/ST by the Central Public Sector Enterprise (CPSE) are as under:

(c)&(e): There is a provision of 3 per cent annual procurement target for MSEs owned by women. This has been made effective from 9<sup>th</sup> November, 2018. Apart from that Ministry of MSME implements various schemes such as Credit Link Capital Subsidy Scheme (CLCSS), Cluster Development Scheme (CDP), Prime Minister Employment Generation Programme (PMEGP) and National Manufacturing and Competitiveness Programme (NMCP) etc for promotion and Development of MSMEs in the country including MSMEs owned by the Women.

(d): For effective implementation of Public Procurement Policy, MSME Sambandh portal has been launched and Review Committee has been constituted.
