### 1322. SHRI ANOOP MISHRA: SHRI BADRUDDIN AJMAL:

Will the Minister of Micro, Small and Medium Enterprises be pleased to state:

- (a) the share of MSMEs products Export in total exports of the country during each of the last three years and the current year;
- (b) whether producers and exporters of MSME Products reportedly lack proper infrastructure and facilities;
- (c) if so, the details thereof and the corrective steps taken in this regard;
- (d) whether the Government has any proposal to encourage the producers and exporters of MSMEs products to adopt new /latest technologies used in other countries for efficient and high quality production to complete in global market; and
- (e) if so, the details thereof and the steps taken in this regard?

#### **ANSWER**

(a): As per the information from Directorate General of Commercial Intelligence & Statistics (DGCI&S), the share of export of specified MSME related Products in the All India exports during each of the last 3 years and current year is as follows:

S. No.	Year	Share of MSME products export.
1.	2018-19(upto Nov.,2018)	47.72%
2.	2017-18	48.56%
3.	2016-17	49.69%
4.	2015-16	49.86%

(b) to (e): In order to help Micro, Small and Medium Enterprises (MSMEs) overcome the constraints on account of access to credit, Common Facilities, high end technologies etc., Government of India has taken several measures. These include efforts made under Make in India Programme, initiatives for promoting Ease of Doing Business, improved availability of credit through MUDRA, Stand up India Programme, 2 percent interest subvention for GST registered MSMEs on fresh or incremental loans, increase in rebate for exporters who receive loans in the preshipment and post-shipment period etc,.

Ministry of Micro, Small and Medium Enterprises, (MSME) implements various policies/schemes/programmes to provide assistance to the producers and exporters of MSME products. Some of such policies/schemes are MSE-Cluster Development Programme (MSE-CDP), Procurement and Marketing Scheme (PMS), Credit Linked Capital Subsidy Scheme (CLCSS), Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE) National Manufacturing Competitiveness Programme (NMCP) etc. These schemes/programmes help MSME growth and increase the competitiveness of enterprises.
