- (a) the number of clusters developed under the Micro, Small and Medium Enterprises (MSMEs) cluster development programme during the last three years, State/UT-wise;
- (b) the turnover and production within each of these clusters during the said period;
- (c) the number of clusters under the said programme that export their products;
- (d) whether the Government has any scheme for the unorganized MSME clusters in the country; and
- (e) if so, the details thereof and if not, the reasons therefor?

- (a): 18 clusters have been completed under Micro and Small Enterprises Cluster Development Programme (MSE-CDP) during last three years. State/UT-wise details are enclosed (Annexure-I).
- (b)&(c): As per the information collected from respective clusters, the details of turnover, production and exports of each of these clusters are enclosed (Annexure-II).
- (d)&(e): The MSMEs, not covered under MSE-CDP scheme can avail of benefits under other schemes of the Ministry such as Scheme of Fund for Regeneration of Traditional Industries (SFURTI), A Scheme for Promoting Innovation, Rural Industry & Entrepreneurship (ASPIRE) etc.
