1523. SHRI MANSHANKAR NINAMA:

Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

(a) the crops for which the Government increases Minimum Support Price each year;

(b) the average increase in Minimum Support Price of these crops during the last three years and the current year, crop- wise and year-wise; and

(c) the impact on inflation and fiscal deficit due to the increase in MSP and the manner in which the Government proposes to contain them?

ANSWER

(a) & (b): Government fixes Minimum Support Prices (MSPs) for 22 mandated agricultural crops and fair and remunerative price (FRP) for sugarcane on the basis of the recommendations of the Commission for Agricultural Costs & Prices (CACP), after considering the views of State Governments and Central Ministries/Departments concerned and other relevant factors. The 22 mandated crops include 14 Kharif crops viz. paddy, jowar, bajra, maize, ragi, arhar, moong, urad, groundnut-in-shell, soyabean, sunflower, sesamum, nigerseed, cotton and 6 Rabi crops viz. wheat, barley, gram, masur (lentil), rapeseed/mustard, safflower and two commercial crops viz. jute and copra. In addition, MSP for toria and de-husked coconut are also fixed on the basis of MSPs of rapeseed/mustard and copra respectively. Details of absolute increase in MSP from 2015-16 to 2018-19 is at Annexure.

(c): Higher MSP does not necessarily imply a proportionate increase in the market price. Price depends on, among others, demand and supply conditions.

Wholesale prices of some of the crops are ruling below MSP reflecting bumper production. This supply response of the farmers owes to incentives in the form of higher MSPs for crops like pulses that had exhibited a chronic shortfall over consumer demand in the earlier years when food inflation was in double digits and overall inflation above comfort zone. To address the issue of wholesale prices trending below MSP in some mandis in some states, procurement has been stepped up and sufficient stocks are there to stabilize prices in contingencies of future shortfall in supply relative to demand.

As regards fiscal deficit, the Fiscal Policy Strategy Statement and the Medium-Term Fiscal Policy Statement, presented by the Government along with the Budget 2018-19 contains the detailed road-map that Government of India has adopted to reduce its fiscal deficit.

Paddy/Rice and wheat are procured for distribution under Public Distribution System (PDS). The difference between the economic cost of the grains/cereals procured and their central issue prices under PDS is the subsidy outgo which is borne on the Budget. The additional financial implication on account of higher MSP for paddy for 2018-19 is estimated to be Rs 12167 crore as estimated by Department of Food and Public Distribution (DFPD) on account of the operationalisation of the principle of keeping MSPs at a level of atleast 150 percent of the cost of production. The budgetary outgo on account of the losses in procurement operations of pulses and oilseeds is the other additionality may not significantly impact the fiscal deficit outcome.
