#### **HOUSES FOR EWS**

No. 1524. SHRIMATI POONAMBEN MAADAM:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) whether the Government has decided to construct houses for the Economically Weaker Sections (EWSs) in urban areas in the country including Gujarat under the Prime Minister AwasYojana (PMAY);
- (b) if so, the details thereof along with the funds sanctioned and the number of housing units constructed under the Yojana during each of the last three years and the current year, State/UT-wise including Gujarat;
- (c) whether various States have asked for financial assistance from Housing and Urban Development Corporation for construction of houses for EWS during the above period;
- (d) whether there has been delays in implementation of the project; and
- (e) if so, the details thereof and the action taken to expedite the implementation process?

#### **ANSWER**

## THE MINISTER OF STATE (INDEPENDENT CHARGE) OF THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI HARDEEP SINGH PURI)

(a)& (b): The Ministry of Housing and Urban Affairs (MoHUA) is implementing the Pradhan Mantri Awas Yojana (Urban) [PMAY(U)] since 25.06.2015 for providing assistance to States/Union Territories (UTs) in addressing housing requirement of the eligible people including Economically Weaker Sections (EWS) in urban areas.

The details of the funds sanctioned and the number of housing units constructed under the Yojana during each of the last three years and the current year, State/UT-wise including Gujarat are at Annexure.

(c): The details of the amount sanctioned by Housing and Urban Development Corporation Ltd. (HUDCO) under Economically Weaker Section (EWS) category and Pradhan Mantri Awas Yojana (PMAY) by HUDCO during the last 3 years and current year 2018-19 (31.01.2019) is as under:-
